INSTRUCTIONS TO BIDDERS

1. OWNER/LOCATION

The work is to be performed at: Walker Park Maintenance Barn, 7601 S Wolf Road, Burr Ridge, Illinois.

2. SCOPE OF WORK

This work shall include removal and replacement of ridge cap, removal and replacement of steel and trim on walls, installation of steel wainscoting, repair of rotted columns, and removal and replacement of steel walk doors and locksets.

3. GENERAL

The Contractor shall supply all labor, transportation, apparatus, scaffolding, any tools necessary for the completion of the work, maintain and remove temporary equipment, and construct in excellent and workmanlike manner the complete work and everything properly incidental thereto as stated in the Contract Documents to set forth in detail every item necessary for the construction of this project. Contractor must be qualified for this work and must, without direction, furnish and install everything necessary to provide construction complete and in acceptable order ready for use without additional work. All areas of the work must be coordinated, complete, and ready to operate and delivered to the Owner in new condition.

Each Contractor shall coordinate his work with any and all other trades and Contractors on the site. The Contractor's work shall be performed in a timely fashion to meet the project time schedule for all work.

5. CONTRACTOR REQUIREMENTS

All interested Bidders shall meet the following requirements in order to Bid this project:

- (a) Minimum bonding capacity by Contractor - \$2,000,000.00. The bonding company must be licensed in the State of Illinois.
- (b) Minimum experience of three (3) years with performance of similar work at more than ten locations.
- (c) Contractors bidding the work shall have their own place of business, equipment, staff, manpower, etc., required for the type of work they are licensed to perform.
- (d) Contractor bidding the project shall have successfully completed similar size and scope projects during the last five years.
- (e) Contractor bidding the work shall provide the necessary financial information to the Owner when requested.
- (f) Bidders must submit with their bids descriptive literature of the items bid as well as a list of references and past projects.
- (g) Contractors bidding the work shall be able to meet the necessary insurance limits required by the Contract Documents. The insurance company shall be acceptable to the Owner (See supplementary general conditions for insurance).
- (h) The successful Contractor shall submit to the Owner a list of subcontractors (if using) not listed on his Bid Form for review and approval by the Owner within three (3) days after being notified that its Bid has been accepted.

6. PROPOSAL (BID) INSTRUCTIONS

6.1 GENERAL

All proposals must be submitted **IN DUPLICATE** and include completed Bidding Documents 4b, 4c, 4h, and 4i, and shall be received in a sealed opaque envelope bearing the name of the Bidder with the following inscription:

All Bids will be firm for a period of 30 days from the date of Bid Opening.

6.2 PERMITS AND FEES

All permits, licenses, tap-on fees, tie-in fees, and any other fees shall be included in this Bid.

6.3 EXCEPTIONS

Any deviation, clarification or exception to these Bid Documents could be cause for rejection of your Bid. Under the State Bidding Laws, exceptions to the Bid could be cause for disqualification of the Bidder.

6.4 BID SECURITY

Bids shall be accompanied by a Bid Security, in the form of a Bid Bond, in the amount of 5% of the Proposal. Failure to submit the proper form and amount of Bid Security may result in rejection of the Bid.

6.5 CONFIRMATION OF ADDENDA

It is the responsibility of each Contractor to determine if any Addenda have been issued by contacting the Park District Office.

6.6 BIDDER'S RESPONSIBILITY FOR CONDITIONS OF WORK AT SITE

Each Bidder shall be knowledgeable of the conditions under which the work is to be performed, the site of the work, the obstacles which may be encountered and all other relevant matters concerning the work to be performed; also, the Bidder, if awarded the Contract, shall not be allowed any extra compensation by reason of any matter which such Bidder might have fully been informed of prior to the bidding.

6.7 TIME SCHEDULE

The Contractor is required to perform the work within the following schedule:

8. RESERVATION OF RIGHTS BY THE DISTRICT

The Owner reserves the right to reject any or all Bids, to waive irregularities, and to accept that Bid which is considered to be in the best interests of the Owner. Any such decision shall be considered final. The Owner reserves the right to set aside a Bid from a Contractor, who, in the Owner's opinion, does not exhibit past experience equal to the size and scope of this project.

9. STATUTORY REQUIREMENTS

All applicable federal and state laws, and the rules and regulations of all authorities having jurisdiction over the project shall apply to the Contract throughout and will deem to be included in the contract the same as

though written therein in full. This includes all current regulations with respect to paying the prevailing wages, including the submission of certified payroll records, and obtaining all necessary permits at the Contractor's expense which shall be incorporated into this project. Additionally, Bidders should be aware that the contract will require compliance with the Americans with Disabilities Act ("ADA"), and all work performed shall comply with the ADA.

Purchases of building materials for incorporation into this project are exempt from the Federal Excise Tax and the Illinois Retailer's Occupation Tax and Use Tax (Sales Tax). The Bidder shall exclude such taxes from consideration in preparing its Bid.

10. NOTICE OF AWARD

The Contract shall be deemed as having been awarded when formal notice of award shall have been duly served upon the intended Contractor by some officer or agent of the Owner authorized to give such notice. Such notice shall be in writing.

11. POST AWARD REQUIREMENTS

Within ten (10) days after receiving the Contract for signature, the Contractor must furnish the Owner with the following:

- a. Executed Agreement between Owner and Contractor;
- b. Performance Bond and Labor and Material Payment Bond or acceptable irrevocable bank letter of credit; and
- c. Certificate of Insurance.

12. CERTIFICATION OF COMPLIANCE WITH ARTICLE 33E OF THE CRIMINAL CODE OF 1961

By signing and submitting with the Bid Form, the Contractor certifies that the Contractor is not barred from bidding on the Contract as a result of a conviction for either bid-rigging or bid rotating under Article 33E of the Criminal Code of 1961.

13. GENERAL CONDITIONS

The General Conditions of this Contract are the AIA Document A201-2007, "General Conditions of the Contract for Construction," 2007 Edition, as modified by the Supplementary General Conditions. The Document is hereby specifically made part of the Contract Documents with the same force and effect as though set forth in full.

The Contractor is directed to the Supplementary Conditions which modify the General Conditions.

14. SUPPLEMENTARY CONDITIONS

The following supplements modify, change, delete from or add to the General Conditions of the Contract for Construction, AIA Document A201-2007:

- (a). Delete Article 11, Insurance and Bonds, in its entirety, replace with the following:

11.1 CONTRACTOR'S LIABILITY INSURANCE

11.1.1 The Contractor shall purchase from and maintain in a company or companies lawfully authorized to do business in the jurisdiction in which the Project is located, such insurance as will protect the Contractor from claims set forth below which may arise out of or result from the Contractor's operations under the Contract, and for which the Contractor may be liable, whether such operations be by the Contractor or by a Sub-contractor or by anyone directly or indirectly employed by any of them, or by anyone for whose acts any of them may be liable:

- .1 claims under workers' or workmen's compensation, disability benefit, and other similar employee benefit acts which are applicable to the Work to be performed;
- .2 claims for damages because of bodily injury, occupational sickness or disease, or death of the Contractor's employees;
- .3 claims for damages because of bodily injury, sickness or disease, or death of any person other than the Contractor's employees;
- .4 claims for damages insured by usual personal injury liability coverage which are sustained (1) by a person as a result of an offense directly or indirectly related to employment of such person by the Contractor, or (2) by other person;
- .5 claims for damages, other than to the Work itself, because of injury to or destruction of tangible property, including loss of use resulting therefrom;
- .6 claims for damages because of bodily injury, death of a person or property damage arising out of ownership, maintenance or use of any motor vehicle; and
- .7 claims involving contractual liability insurance applicable to the Contractor's obligations under Section 3.18.

11.1.2 The insurance required by Subsection 11.1.1 shall be written for not less than limits of liability specified in the Contract Documents, or required by law, whichever coverage is greater. Coverages, whether written on an occurrence or claims-made basis, shall be maintained without interruption from date of commencement of the Work until date of final payment and termination of any coverage required to be maintained after final payment. Notwithstanding the above, the insurance required by Section 11.1 shall be on an occurrence basis.

11.1.2.1 Such insurance shall be written to include the following coverages and for not less than the minimum limits indicated on the sample Certificate of Insurance included in these specifications or greater if required by law:

- .1 Worker's compensation, Occupational Disease and Employer's Liability Insurance:
 - A. State: (in which this contract is performed) – Statutory limits.
 - B. Applicable Federal (if any) – Statutory limits.
 - C. Employer's Liability: Bodily Injury by Accident; Bodily Injury by Disease each employee; Bodily Injury by Disease policy limit.
- .2 Commercial General Liability Insurance including as minimum coverages:

Premises – Operations Liability – Independent Contractor’s Protective Liability – Products and completed Operations Liability – Board Form Property Damage Endorsement – Blanket Contractual – Personal Injury, with Employment Exclusion deleted.

A. Special Requirements:

- i. Property Damage Liability Insurance will provide “X, C, and U” (Explosion, collapse and underground hazard) coverage as applicable.
- ii. Products and completed Operations to be maintained for one (1) year after final payment. Damage to material, product or item of equipment itself shall be covered by an Installation Floater on a legal liability basis or by an extension of the manufacturer’s warranty.
- iii. The term “caused by accident” if used in bodily injury coverage shall be replaced by the term “occurrence”.
- iv. The term “caused by accident” if used in property damage coverage shall be replaced by the term “occurrence.”
- v. The Owner shall be named as “additional insured” on the commercial general liability policy of the General Contractor and/or Subcontractor of any tier.

B. Limits of Liability:

- .3 Automobile Liability: Any Auto Owned by Contractor, hired autos, non-owned autos.

Limits: \$1,000,000

Combined Single Limit \$1,000,000

- .4 Umbrella/Excess Liability Insurance: In addition to the insurance coverages set forth in the Contract Documents, the Contractor shall maintain an umbrella/excess liability policy with coverages for the same hazards as covered under the primary policies, including any special requirements.

11.1.3 Certificates of Insurance for the above coverages shall be submitted to the Owner for approval prior to the start of construction. The Contractor shall certify to the Owner that he has obtained or will obtain similar certificates of insurance from each of his Subcontractors before their work commences. Each Subcontractor must be covered by insurance of the same character and in the same amounts as the Contractor unless the Contractor and Owner agree that a reduced coverage is adequate. Each Subcontractor’s insurance shall cover the Owner, its agents, and employees. The Contractor shall submit a statement with each monthly

affidavit stating that he has obtained certificates of insurance, or other satisfactory evidence, that all required insurance is in force for each of the Subcontractors listed on his affidavit. If the "additional insured's" have other insurance which is applicable to the loss, it shall be on an excess or contingent basis. The amount of the company's liability under this policy shall not be reduced by the existence of such other insurance. Contractor's certificates shall be in duplicate on Acord 25-S Certificate of Insurance Form.

11.1.3.1 Certificate of insurance shall contain a statement therein or a rider attached thereto incorporating the indemnity clause stated in Section 3.18 (Indemnification) and Subsections 3.18.1, 3.18.1.1, 3.18.2, 3.18.3, 3.18.4, and 3.18.5 of the General Conditions, and including the changes and addition made in those Subsections within these Supplemental General Conditions.

11.1.3.2 These Certificates and the insurance policies required by this Section 11.1 shall contain a provision that coverages afforded under the policies will not be canceled or allowed to expire until at least thirty (30) days prior written notice has been given to the Owner. If any of the foregoing insurance coverages are required to remain in force after final payment and are reasonably available, an additional certificate evidencing continuation of such coverage shall be submitted with the final Application for Payment as required by Subsection 9.10.2. Information concerning reduction of coverage shall be furnished by the Contractor with reasonable promptness in accordance with the Contractor's information and belief.

11.2 OWNER'S LIABILITY INSURANCE

11.2.1 The Owner shall be responsible for purchasing and maintaining the Owner's usual liability insurance. Optionally, the Owner may purchase and maintain other insurance for self-protection against claims which may arise from operations under the Contract. The Contractor shall not be responsible for purchasing and maintaining this optional Owner's Liability Insurance unless specifically required by the Contract Documents.

11.3 PERFORMANCE BOND AND PAYMENT BOND

11.3.1 The Owner shall require the Contractor to furnish bonds covering faithful performance of the contractor and payment of obligations arising thereunder as stipulated in bidding requirements or specifically required in the Contract Documents on the date of execution of the Contract.

11.3.2 Upon the request of any person or entity appearing to be a potential beneficiary of bonds covering payment of obligations arising under the Contract, the Contractor shall promptly furnish a copy of the bonds or shall permit a copy to be made.

11.3.3 The Contractor, before commencing the Work, shall furnish a Performance Bond and a Labor and Material Payment Bond. The Performance Bond shall be in an amount equal to 100 percent of the full amount of the Contract Sum as security for the faithful performance of the obligations of the Contract Documents and the Labor and Material Payment Bond shall be in an amount equal to 100 percent of the full amount of the Contract Sum as Security for the payment of all persons performing labor and furnishing materials in connection with the Contract Documents. Such bond shall be on AIA Document A-312, issued by the American Institute of Architects, shall be issued by a surety satisfactory to the Owner and shall name the Owner as a primary co-obligee.

11.3.4 In the event the contract amount is less than one hundred thousand (\$100,000) dollars, a non-diminishing irrevocable bank letter of credit may be substituted for the performance and payment bonds, provided that such letter of credit is acceptable to the Owner.

11.4 MISCELLANEOUS REQUIREMENTS

11.4.1 All insurance coverage shall be provided by insurance companies having policy holder ratings no lower than "A" and financial ratings not lower than "XII" in the Best's Insurance Guide, latest edition in effect as of the date of the Contract.

11.4.2 The Contractor is responsible for determining that Subcontractors are adequately insured against claims arising out of or relating to the Work. Each Subcontractor shall pay the premium cost and charges for such insurance.

11.4.3 The limits of liability as stated may be arrived at using a Split-Limit or a Combined Single Limit basis. However, the total limit of liability shall not be less than stated in the requirements.

15. SPECIAL PROVISION FOR FAIR EMPLOYMENT

Equal Employment Opportunity Policies: For the entire duration of his work under the Contract, the Contractor shall conform to the federal and the state statutes on equal opportunity and fair employment.

16. SPECIAL PROVISIONS FOR PREDETERMINED PREVAILING WAGE

Contractor acknowledges and certifies the Project calls for the construction of a "public work," within the meaning of the Illinois Prevailing Wage Act, 820 ILCS 130/0.01, *et seq.*, and it agrees to fully comply with all provisions thereof, as amended, and to ensure compliance therewith from any subcontractor on the Project. The Contractor understands that the "prevailing rate of wages" (hourly cash wages plus fringe benefits) in Cook County will govern this Project, and those rates, and any changes thereto, will be found at Illinois Department of Labor's website at: <http://www.state.il.us/agency/idol/rates>, and that no further or additional notification by the District as to the revised prevailing wage rates is expected or will be given to Contractor.

17. DRUG FREE WORKPLACE:

SPECIFICATIONS FOR WALKER PARK MAINTENANCE BARN RESKIN FOR THE PLEASANT DALE PARK DISTRICT

Overview

The Pleasant Dale Park District seeks bids for the reskin of the maintenance barn at Walker Park located at 7601 S Wolf Road, Burr Ridge, Illinois. Bids shall include all costs, including labor, materials and bonds.

1.0 GENERAL

1.01. EXECUTION

- A. Work Included: The contractor shall provide labor, materials and all necessary accessory items for the reskin of the maintenance barn at Walker Park. Contractor to verify the measurements provided in specifications. Please refer to Exhibit A to this document for additional details.
- B. Quality Assurance: The contractor shall provide laborers and supervisors who are thoroughly familiar with the type of construction involved and the materials specified.
- C. Submittal: Prior to commencement of the work, the contractor shall provide samples and documentation necessary to confirm compliance with specified materials.
- D. Cleaning: Contractor shall recover and remove all excess materials from the job site.
- E. Safety Considerations: Fall protection gear and equipment for all work over 6' will be utilized.

1.02. RUBBISH

At the completion of each workday, remove all cartons, rubbish, or any other accumulated materials caused by this work and leave the premises in a clean and acceptable condition.

1.03. WARRANTY

- A. Contractor shall provide 40-year warranty for panels to replace or repair where paint separates due to cracking. Contractor shall also provide a lifetime warranty against fastener red rust.

2.0 RIDGE CAP

2.01 PREPARATION

- A. Remove existing ridge cap (60 LF) and discard
- B. Remove existing pipe boot and discard

2.02 EXECUTION

- A. Furnish and install new vented steel ridge cap (60) LF) at peak with uninvent closures
- B. Fasten ridge cap with 300 Series stainless steel cap hex head self-sealing screws
- C. Install new 4"-7" high temp dek-tite boots around pipes through roof

3.0 SIDING

3.01 PREPARATION

- A. Remove corner trim (49 LF) from existing building
- B. Remove walk door and window trim (43 LF) from existing building
- C. Remove existing overhead door flashing (66 LF)
- D. Remove existing track cover and discard (46 LF)
- E. Remove existing door track and discard (46 LF)
- F. Remove steel siding from existing walls and gables (2554 SF)

3.02 EXECUTION

- A. Install new overhead door flashing (66 LF)
- B. Install new 1" x 3" furring strips above overhead doors so flush with new wall steel (52 SF)
- C. Install new vertical 2" x 4"s to ensure vertical overhead door is flush (40 SF)
- D. Install new drip cap at base of existing walls (174 LF)
- E. Install new Max Rib Steel on walls and gables of existing building (3948 SF)
- F. Install new vertical corner trims on existing building (49 LF)
- G. Fasten all steel and trims with 300 Series stainless steel cap hex head self-sealing screws
- H. Install 36" wainscot on entire structure (174 LF) (Not door area)
- I. Provide 3 extra sheets of new wainscot panel for park district future use (9 SF)
- J. Install inside gasket closure at wainscot (Top & bottom of Z-trim 348 LF)

4.0 ROTTEN COLUMNS WITH DIRT/GRAVEL FLOOR

4.01 PREPARATION

- A. Remove existing 2" x 8" treated center match and discard (174 LF)

4.02 EXECUTION

- A. Install new 2" x 8" treated center match grade board along perimeter of building

5.0 STEEL WALK DOORS AND LOCKSETS

5.01 PREPARATION

- A. Remove existing steel walk doors and discard
- B. Rough opening for new walk door is 38.25" x 82.5"
- C. Frame out for new walk door in sidewall

5.02 EXECUTION

- A. Install new 3' x 6' x 8" steel insulated walk door with steel fram (trim to be included)
- B. Install new grade 2 commercial knob lockset for steel walk door
- C. Cut existing steel siding to fit around new walk door (17 LF)

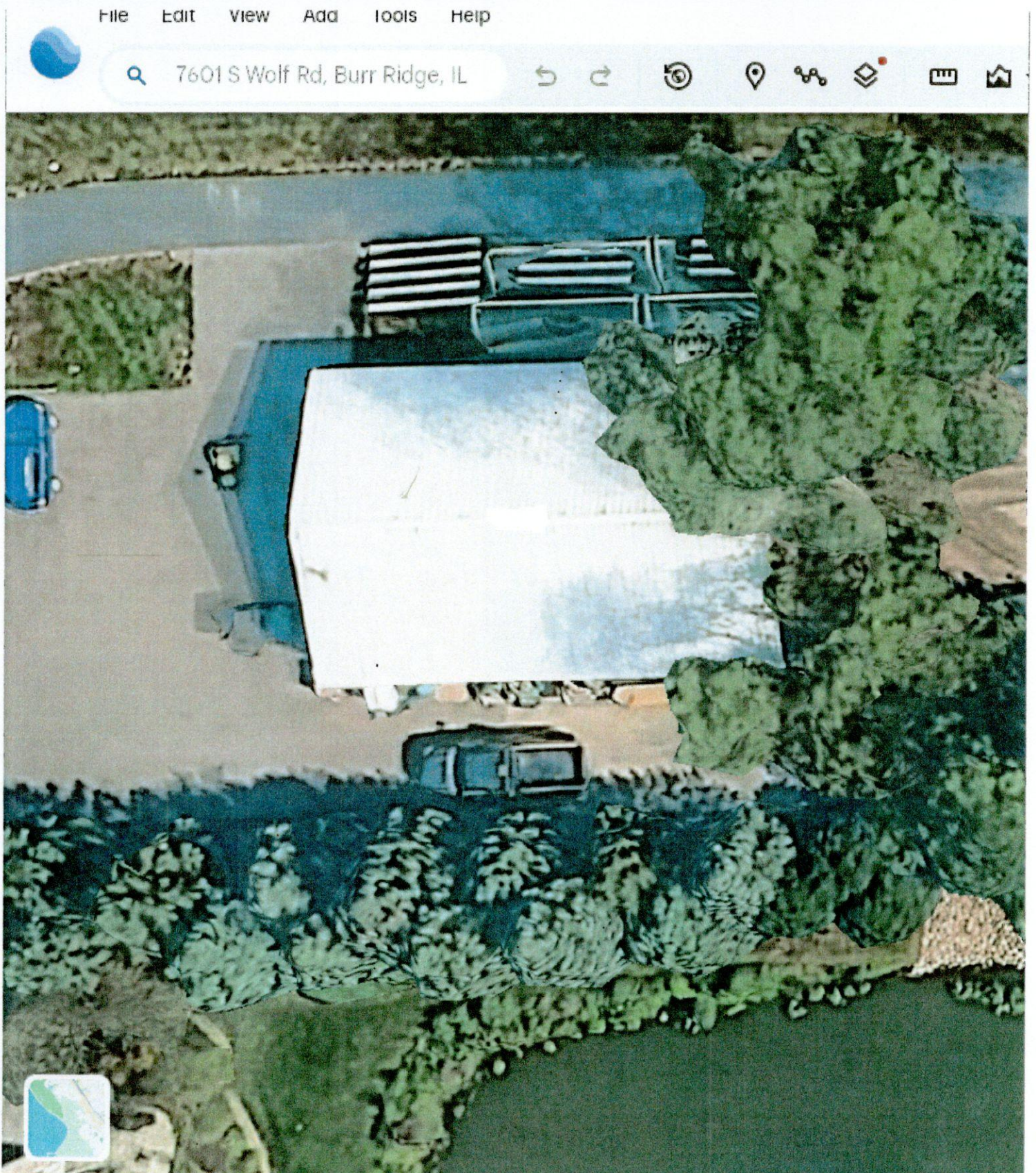

The Contractor shall: a) make and keep, for a period not less than 5 years, records of all laborers, mechanics, and other workers employed by them on the Project; b) the records shall include each worker's name, address, telephone number when available, social security number, classification or classifications, the worker's gross and net wages paid in each pay period, the number of hours worked each day, and the starting and ending times of work each day, the worker's hourly wage rate, worker's hourly overtime wage rate, worker's hourly fringe benefit rates, the name and address of each fringe benefit fund, the plan sponsor of each fringe benefit, and the plan administrator of each fringe benefit; and c) submit to the Illinois Department of Labor, no later than the 15th day of each calendar month, a certified payroll for the preceding month through an electronic database capable of accepting and retaining certified payrolls in accordance with the Prevailing Wage Act. Upon two (2) business days' notice, the Contractor shall make available for inspection the records identified in the Prevailing Wage Act to the Park District, and to the Director of Labor and his deputies and agents. Upon two (2) business days' notice, the Contractor shall make such records available at all reasonable hours at a location within this State. Contractor shall be responsible for ensuring all subcontractors comply with this paragraph, and it shall be solely responsible for ensuring the record keeping and submissions required under this paragraph are complied with by subcontractors. To the extent that there are any violations of the Prevailing Wage Act and any demands are made upon the Park District, the Contractor shall be responsible for indemnifying and holding the Park District free and harmless from all costs incurred, directly or indirectly, by the Park District in responding to and complying with demands made by the Department of Labor, or an aggrieved employee.

2. Contractor acknowledges and certifies the contract for the Project shall be governed by, and Contractor shall fully comply with, all state and local non-discrimination laws. The Contractor certifies that it is in full compliance with the requirements of the Illinois Human Rights Act, 775 ILCS 5/1-101 *et seq.*, including that it has in place a written sexual harassment policy that includes, at minimum, the following information: a) the illegality of sexual harassment; b) the definition of sexual harassment under state law; c) a description of sexual harassment, utilizing examples; d) the Contractor's internal complaint process including

penalties; e) the legal recourse, investigation and complaint process available through the Department and the Commission; f) direction on how to contact the Department and Commission; and g) protection against retaliation as provided by Section 6-101 of said Act. The Contractor further certifies that it shall: a) refrain from unlawful discrimination and discrimination based on citizenship status in employment and undertake affirmative action to assure equality of employment opportunity and eliminate the effects of past discrimination; b) comply with the procedures and requirements of the Department's regulations concerning equal employment opportunities and affirmative action; and, c) provide such information, with respect to its employees and applicants for employment, and assistance as the Department may reasonably request; and d) include verbatim or by reference the provisions of this clause in any subcontract so that such provisions will be binding upon such subcontractor. In addition, the Contractor certifies that it will not utilize any subcontractor declared by the Illinois Human Rights Commission to be ineligible for contracts or subcontracts with the State of Illinois, its political subdivisions or municipal corporations. Contractor, at the time Contractor submitted its proposal, had an Illinois Department of Human Rights pre-qualification number or had a properly completed application for same on file with the Illinois Department of Human Rights, as provided for in 44 Illinois Administrative Code 750.210.

3. Contractor acknowledges and certifies that the contract for the Project, will be governed by, and Contractor shall fully comply with, all federal Equal Employment Opportunity Laws, including, but not limited to, the Americans with Disabilities Act, 42 U.S.C. §12101, *et seq.*, and rules and regulations promulgated thereunder.

4. The Contractor acknowledges and certifies that in the event the costs of the Project exceeds \$75,000, the contract for the Project will be governed by, and Contractor shall fully comply with, the requirements of the Illinois Construction Contract Act, 30 ILCS 557/1, *et seq.*

5. The Contractor acknowledges and certifies that in the event the cost of the Project exceeds \$150,000, the contract for the Project will be governed by, and Contractor shall fully comply with, the requirements of the Illinois Public Construction Bond Act, 30 ILCS 550/1, *et seq.* The Contractor certifies that its labor and material payment bond shall include a clause providing for the payment of all laborers, workers and mechanics performing work on the Project according to the prevailing wage rates applicable to Cook County as revised by the Illinois Department of Labor.

6. The Contractor acknowledges and certifies that the contract for the Project will be governed by, and Contractor shall fully comply with, the requirements of the Illinois Employment of Illinois Workers on Public Works Act, 30 ILCS 570/0.01, *et seq.*

7. The Contractor acknowledges and certifies that in the event the contract for the Project was put out and awarded through bidding it will be governed by, and Contractor shall fully comply with, the requirements of the Illinois Public Works Contract Change Order Act, 50 ILCS 525/1, *et seq.*

8. The Contractor acknowledges and that the contract for the Project will be governed by, and Contractor shall fully comply with, the requirements of the Local Governmental Prompt Payment Act, 50 ILCS 505, *et seq.*, and that it shall make payments to its subcontractors and material suppliers as required by Section 9 thereof.

9. The Contractor acknowledges and certifies that it shall Contractor shall fully comply with the requirements of the Illinois Wage Payment and Collection Act, 820 ILCS 115/1, *et seq.*

10. The Contractor acknowledges and certifies that the contract for the Project will be governed by, and Contractor shall fully comply with, the requirements of the Illinois Veterans Preference Act, 330 ILCS 55/0.01, *et seq.*

11. The Contractor acknowledges and certifies that the contract for the Project will be governed by, and Contractor shall fully comply with, the requirements of the Illinois Drug Free Workplace Act, 30 ILCS 580/1, *et seq.*, including provision of providing notifications, imposing sanctions, providing assistance with counseling, and complying with all other requirements of said Act. Pursuant thereto, Contractor represents that it will provide a drug-free workplace by:

A. publishing a statement: (i) notifying employees that the unlawful manufacture, distribution, dispensation, possession, or use of a controlled substance including cannabis, is prohibited in Contractor's workplace; (ii) specifying the actions that will be taken against employees for violations of such prohibition; (iii) notifying employees that, as a condition of employment on the Project, the employee will: (a) abide by the terms of the statement; and (b) notify the employer of any criminal drug statute conviction for a violation occurring in the workplace no later than five (5) days after such conviction;

B. establishing a drug-free awareness program to inform employees about: (i) the dangers of drug abuse in the workplace; (ii) its policy of maintaining a drug-free workplace; (iii) any available drug counseling, rehabilitation, and employee assistance program; and (iv) the penalties that may be imposed upon employees for drug violations;

C. making it a requirement to give a copy of the statement required by Subsection A to each employee engaged in the performance of the Contract, and to post the statement in a prominent place in the workplace;

D. notifying the Park District within ten (10) days after receiving notice from an employee or otherwise receiving actual notice of such conviction;

E. imposing a sanction on, or requiring the satisfactory participation in a drug abuse assistance or rehabilitation program by any employee who is so convicted, as required by 30 ILCS 580/5;

F. assisting employees in selecting a course of action in the event drug counseling treatment and rehabilitation is required and indicating that a trained referral team is in place; and

G. making a good faith effort to continue to maintain a drug-free workplace through implementation of this section.

Contractor further certifies that it is not ineligible for the award of the contract for the Project by reason of debarment for a violation of the Illinois Drug-Free Workplace Act.

12. The Contractor acknowledges and that the contract for the Project will be governed by, and Contractor shall fully comply with, the requirements of the Substance Abuse

Prevention on Public Works Act, 820 ILCS 265/1, *et seq.* Specifically, employees of the Contractor and employees of any subcontractor shall be prohibited from the use, possession, distribution, delivery, or from being under the influence of drugs or alcohol while performing work on the Project. The Contractor certifies, and shall ensure that each subcontractor certifies, as follows (check one): _____ that it has in place a written Substance Abuse Prevention Program for the prevention of substance abuse among its employees, a copy of which Contractor will submit upon being awarded the contract for the Project, which meets or exceeds the requirements set forth in the Substance Abuse Prevention on Public Works Act; or _____ has a collective bargaining agreement in effect dealing substance abuse while working on the Project.

13. The Contractor certifies that it is in compliance with Illinois laws governing bidding and is not barred from bidding on the Project as a result of a conviction for violating Section 33E-3 (bid rigging) or 33E-4 (bid-rotating) of the Criminal Code of 1961 (720 ILCS 5/33E-3 and 5/33E-4).

14. The Contractor certifies that it is not delinquent in the payment of any tax administered by the Illinois Department of Revenue unless the tax is being contested in accordance with the procedures established by the applicable statute at issue. For purposes of this certification, the Contractor shall not be deemed delinquent if it: (a) has entered into an agreement with the Department of Revenue for the payment of all such taxes that are due; and (2) is in compliance with the agreement; provided Contractor shall notify the Park District and supplement this certification prior to being awarded the contract for the Project with facts supportive of aforementioned exception, if applicable.

15. Contractor certifies that it has examined and understands the scope of each of the aforementioned laws and their effect on the contract and Project, and that Contractor's proposal, and more specifically the proposal amount identified in the Estimate, reflects such applicability and Contractor's compliance therewith at all times.

16. Contractor certifies that it is in good standing with the State of Illinois and the Village of Burr Ridge, and that it is qualified and eligible for permits and licenses from said authorities and agencies and departments thereof that will be necessary to complete the Project, and has not been subject to any adverse action by those authorities within the past five (5) years.
